PATTERSON POINT: RESTORATION & CHALLENGES

Our ninth season at Patterson Point Preserve, which just ended, had us dealing with emergencies while pursuing our long range restoration plans. We began last fall by felling a diseased redwood next to the path; a week later, a large limb from the bay at the bottom of the path split off the main trunk. An ar-

borist was already scheduled to thin the bay forest near the upper path and he took care of the split limb at the same time.

Stewards and volunteers continued to remove ivy from deep within the Preserve, and new native plant seedlings were added to formerly weeded areas. Thanks to all who help out!

To help with the ongoing and emergency costs of PPP, a donor has offered to match contributions earmarked for the Preserve up to \$1,000. All funds raised from this campaign will be targeted specifically to the restoration efforts on Patterson Point Preserve.

NOD-A-WAY AND THE GIROT FAMILY

Among the most historic homes in Villa Grande is the charming "Nod-a-Way" cottage at the end of 2nd Avenue past Russian River Avenue. Probably built by the railroad or an early settler, the home was sold to the Schneider family in 1911. The family retains a 1906 note that asks the house to be relocated to the riverside corner of the property before moving in.

The Schneiders had five children, a daughter who drowned in 1914 near the cottage and another daughter who never married and died in 1928. The two sons, George and

Nicholas, began the successful furrier "Schneider Brothers" on Post Street right next to the original Gump's in San Francisco. The third daughter, Charlotte "Lottie' Schneider, married Alfred Girot who helped his brothers-in-law run the family fur business.

Alfred and Lottie had two children, George (Popsie) and Alfred, Jr. who ran the Schneider Brothers until it closed in the 1980's. Popsie remembered as a child the family taking the J Church streetcar from Noe Valley to the Ferry Build-

streetcar from Noe Valley to the Ferry Building and boarding the 8 a.m. ferry to Sausalito on the top deck. There, they caught the train to Santa Rosa, where they transferred to the Guerneville line, which stopped at Rio Nido, Guerneville, Northwood (then called Rio Campo) arriving in Villa Grande at noon, with the train whistle calling kids home for lunch.

By the end of the 1930's, Alfred and Popsie were the surviving owners of Nod-a-Way. Popsie later purchased Alfred's share in the property though Alfred continued visiting Villa Grande, since he married Annette Jansen, first cousin to Gladys Jansen Vail,

who still owns property at the end of Willow Road.

Another summer resident, Barbara (Baba) Annis, spent time in Villa Grande as a young girl and teenager, staying at her uncle Lou Kingsley's place either above the store or at his house on Russian River Avenue (aka the Garden House). Baba was an excellent piano player so Popsie taught himself to play piano while he was a teenager, just so he could meet her. They were high school sweethearts, and they married in 1940.

One of Popsie's best friends was Bill Edwards, who owned the home now occupied by the Bornsteins a few doors down Russian River Avenue. After WWII, veterans Popsie and Bill had an ongoing horseshoe tournament that went on year after year. A chalk board with the score from a game they played in 1947 still hangs in the garage next to the house.

After Popsie's death in 2008, his children, Suzanne and George Jr., continued to use the cottage jointly until Suzanne's passing in 2014. George still remembers as a child coming to the river for whole summers where he learned to swim, boat and fish. He shares his father's love of old cars. Popsie owned 19 Buicks in his lifetime, including a classic 1938 model that George now owns. Villa Grande is blessed with families that have anchored this community for generations, including the Girots.

RIVER RECREATION RECOMMENDATIONS - WATER QUALITY

Last summer, water quality in the Russian River was poor due to high bacterial counts. The beach at Monte Rio was posted by the County as unsafe for swimming July 5-12. There is a correlation between the high counts at Monte Rio and Patterson Point, especially when the river mouth is closed, though our beach never quite reached the unsafe level.

The river after July 4 also had mats of floating algae and County testing found low levels of (toxic) anatoxin-a at Patterson Point. This toxin comes from blue green algae and is highly poisonous to dogs. It also causes problems for infants and persons with compromised immune systems. The County recommends:

- Stay away from algae in the water or on the shore.
- Do not drink or cook with river water.
- Don't let pets drink water, or lick scum at the shoreline.
- For any fish caught, throw away guts and clean fillets with tap or bottled water before cooking.
- Shower after river play, especially children and pets. If dogs lick their wet fur, they could ingest the toxin.

VILLA GRANDE POST OFFICE 101

Of course one shouldn't need a guide to using their post office, but maybe we do in Villa Grande. Although we have free post office boxes instead of home-based delivery, mail sent to a street address can be "returned to sender" if the PO box is not included. This is a problem for a vendor, such as Amazon, that doesn't allow PO boxes as addresses.

Our postmaster, Luke, suggests some alternatives in these cases. Simply include your POB number after your name when entering the address for an online order. Alternatively, place the POB

in the second address field usually reserved for apartment numbers.

Also, did you know mail placed in the blue mailbox is not picked up directly by the mail driver? All mail is first processed by Luke and then placed in the locked green mailboxes in front to be picked up by the driver at the times shown on the blue boxes! If you're concerned about making a pickup time, it's best to drop your outgoing mail in the "local" (Villa Grande) or "other" slots inside the lobby.

Town Hall: Topics that Matter in Villa Grande

On Sunday, June 3, at 11 a.m. in the Firehouse Plaza, all locals are invited to attend a Town Hall to hear about and discuss three issues.

Emergency Preparedness

After last fall's devastating fires, many Villa Grande residents realized how unprepared we were to respond to natural disasters. Facilitated by Erin McKinney, thirty local residents met several times and mapped out disaster preparedness strategies for fires, floods and earthquakes.

Committees have been focusing on response tasks, including Emergency Evacuation, Personal Preparedness, Contact/Communications and Medical Support. Come hear about how you might be better prepared and be ready to help others in the event of a disaster.

Community Identification

Residents of Villa Grande, including many in the Terraces, have expressed frustration with commercial companies and services that conflate us with Monte Rio. Since many street names are similar, emergency responders have been known to go to the wrong address in Monte Rio instead of Villa Grande. Several residents have begun a dialog with County officials about revising the "Community Identifier" for Villa Grande, and are including Terraces residents as well. A survey is being prepared for public distribution, which will include background information.

Septic Update

There has been a lot of activity and discussion regarding the new standards for septic systems along the River. The issue is on the agenda for the May 8, 2018, Sonoma County Board of Supervisors meeting. Rich Holmer and Kyla Brooke serve on the Ad Hoc Committee of On-site Wastewater Treatment Systems - Residents of the Russian River, which is committed to working with government entities to develop reasonable regulations. A member of this committee, Pat Abercrombie, prepared a question and answer summary included with this newsletter.

PROPANE DISCOUNT EXTENDED

We are pleased to announce that Kyra Wink, FoVG Membership Chair and Chris Love, AmeriGas's General Manager, have worked to extend the discounted propane program for FoVG members. The contract is for two years, then renewable for another two, and it should keep the discount at the same level it has been since 2017.

The new contract redefines the FoVG-Amerigas service area to be above and below Moscow Road from Main Street/Bohemian Highway to

Casini Ranch. Current members outside this smaller area will be grandfathered in and may keep the FoVG discount as long as they remain members in good standing by paying FoVG annual dues by September of each year.
